Conditions of Entry

1. Information on how to enter and prizes form part of these conditions. By participating, entrants agree to be bound by these conditions. Entries must comply with these conditions to be valid.
2. The promotion is open to financial 2018 Cronulla RSL members.
3. Entry is open to residents of NSW who are 18 years and over and who are current full financial members of Cronulla RSL. Employees of the Promoter and its agencies and venues associated with this promotion are ineligible to enter. Social members, Directors and Employees of The Club and related companies are excluded from entering this promotion. Entrants acknowledge that the Club is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.
