

Conditions of Membership



Cronulla RSL Memorial Club Limited

1. By applying for membership of Cronulla RSL Memorial Club Ltd you are agreeing to abide by the Constitution Rules and By-Laws of the Club at all times.

3. Your application for membership will be subject to the approval of the Board of Directors of the Club. If your application is unsuccessful you will be advised and your membership fee will be refunded.
4. Only one membership per person is permitted.
5. Membership term is charged at a minimum of 12 months.
6. Participation in the Club's Member Loyalty Program is only available when membership is financial.
7. Cronulla RSL Memorial Club Ltd may terminate a membership without notice for any reason including, without limitation, if the member:
 - fails to comply with these membership terms and conditions;
 - fails to comply with the bi-laws and constitution of the Club
 - abuses any privilege accorded to the member under the membership terms
 - supplies any misleading information or make any misrepresentations to Cronulla RSL Memorial Club Ltd
8. The decisions of management in relation to the operation of the membership program are final.
9. Membership cards are not credit or charge cards, and remain the property of Cronulla RSL Memorial Club Ltd.
10. Under no circumstances are membership cards transferable. Should any member lend his/her card and it becomes known, then both the member and the recipient will be subject to disciplinary proceedings under the Constitution.
11. It is the member's responsibility to ensure their membership card is properly inserted into the card reader and is generating bonus points. Any play accumulated without your card properly inserted will not generate points.
12. Management reserves the right to adjust all points, promotional prize tickets and gift vouchers of any member resulting from malfunction, operation error or any kind of misrepresentation.
